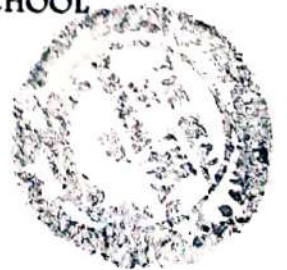



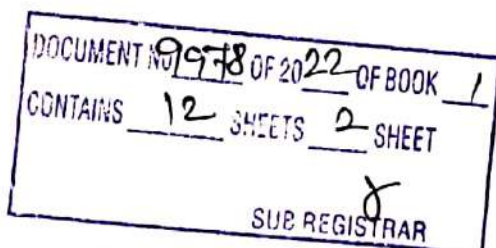

3. WHEREAS both the Lessor and Lessee agreed to the following terms and conditions set below:
1. That the Lessor agrees to lease out the land and building more fully described in the schedule below to the lessee for a period of 32 Years from the date of its commencement.
